President's Corner - Fall 2017

Neighbors,

I hope everyone had an enjoyable summer and is relishing the cooler fall temperatures that have finally arrived. Recently, all homeowners should have received a large mailing from The Select Group announcing the annual meeting, the Board of Directors candidate forms with proxy for elections and finally the two proposed amendments to the Declarations with voting proxy. The annual meeting this year is scheduled for Monday, November 20th at 6:30pm in the meeting rooms of the Bayside Recreation Center. Registration will begin at 6:00PM. In addition to reviewing the 2017 budget, we will also be holding annual elections for Board positions with three incumbent Board members up for re-election this year – Chris Caporicci, Jack Palmer, and Neil Bonney. If you are unable to attend the annual meeting to vote in person, please mail your election voting proxy back to The Select Group.

After numerous deliberations and time spent with our association attorney, The Board has drafted two proposed amendments for changes in our Declarations related specifically to rental properties. It is imperative that all homeowners review the proposed amendments and vote on them in person at the annual meeting or via the proxy form that must be signed and mailed back to The Select Group with your vote. The first amendment change is to limit the lease duration for rentals to a period no less than 1 year. We have recently had several significant challenges with renters in the community and, in the course of trying to resolve the issues; it became apparent that the homeowner was renting this home on a month to month basis with no background checks on their tenants. Additionally, this amendment is to stay ahead of the growing trend of homeowners' renting through Airbnb in which homes can be rented for short durations such as a just a day, a weekend or a month.

The second proposed amendment change to the Declarations is to impose a rental cap on the neighborhood. This is a precautionary move to again stay ahead of trends and ensure Church Point remains primarily a community of single family homes where homeowners live and reside. Church Point is currently at approximately 13% rentals and the proposed amendment rental cap would be placed at 15%. This allows all current owners who are renting their homes to be grandfathered for approval to rent provided compliance with the amendments. If there are any questions or clarifications needed for either of the proposed amendments to the Declarations, please attend the annual meeting so they can be addressed and discussed.

Finally, the Board is executing some major renovation and refurbishment projects focusing on the bridge as well as the asphalt paths. The bridge will have rotting wood addressed, and be cleaned and seal coated with the lighting restored where sections have been knocked out. Similar work will be performed at the Gazebo. Along the asphalt paths, new supplemental drainage is being installed along the longer Gazebo path that connects to Thoroughgood. Additionally, all paths are being refurbished, to include the elimination and replacement of multiple trip hazards from root uplifts, and a new seal coat. I look forward to seeing everyone at the annual meeting on November 20th.

Fall is here and it is getting dark sooner each day. Although things have been fairly calm in our neighborhood, we need to always stay vigilant. The VBPD 3rd Precinct is reporting a 20% increase in robberies, motor vehicle thefts and break-ins over this same time frame last year. The most common home burglary tactic being reported is when one person knocks on your front door, and if no one answers, another will go around to the back door and break in. This is happening both during the day and at night so please be cautious this holiday season and keep an eye out for your neighbors also. If you notice anything suspicious or unusual activity, call the police non-emergency number at 385-5000.

Please don't leave your cars unlocked and especially don't leave your keys/key fobs in your car. Captain Orr from the 3rd Precinct stated in the last Citizens Advisory Meeting, that people are leaving their cars unlocked with keys/key fobs in the cars. The thieves are just pushing the start buttons and driving away with the car.

The Church Point Neighborhood is part of the traffic calming program for the 3rd Precinct. This program allows the police to add an additional \$200 fine to the amount of a regular speeding ticket in the neighborhood. The average cost for a speeding ticket as part of this program is \$350. For communities participating in the Traffic Calming Program, the average percentage of the speeding tickets written in a community going to actual residents of that community is 30%. Church Point leads the city with 70% of all the tickets being written for speeding going to our own residents. This is not a statistical category that we want to be leading. PLEASE slow down on our streets and abide by the 25 MPH speed limit.



AREC Corner - Fall 2017

It was nice this summer to see many homeowners submitting Architectural Change Applications to improve their homes including new pools and pool houses. Unfortunately, we did notice homeowners executing improvements and changes without reading the rules or even submitting applications for approval prior to starting projects. The rules are in place for the primary reason of ensuring consistency and uniformity of the homes to maintain curb appeal and most importantly home values. There is a designated process for making changes to the exterior of your home and that process requires the submittal of an AREC application (with details of the plan and notification of your neighbors) to the Select group and approval by the Board of Directors prior to commencing the work. The process is quick with responses back usually within 30 days if submitted in advance of the monthly Board meeting. If ever in doubt or if you have questions prior to submitting applications, please don't hesitate to contact AREC via email at arec.churchpointhoa@gmail.com.

Fall brings the changing color of leaves and their eventual falling to the ground. Unfortunately, year after year, we need to remind homeowners that leaves must be bagged in clear yard waste bags for pickup by the city and in accordance with HOA rules, cannot be placed on the curb in front of your home any earlier than Tuesday (the day before trash pickup - which is of course Wednesdays). Please keep this in mind and please don't place your lawn debris and leaf bags on the curb prior to Tuesday. Most of us, who don't have lawn service during the week, use the weekends for yard work. Please store your bags behind the rear foundation of your home, out of site from the street, until Tuesday. The weekends are popular times for friends and family to visit as well as prospective homeowners to tour the neighborhood looking for homes. What they don't want to see are our streets lined with leaf bags or yard debris. It is not the appearance or welcoming look we want to portray for perspective new neighbors in Church Point. Curb appeal affects all homeowners, so please do your part to help us maintain our community.
