#### President's Corner - Fall 2018

Neighbors,

I hope everyone had an enjoyable summer and is relishing the cooler fall temperatures that have finally arrived. Recently, all homeowners should have received a mailing from The Select Group announcing the annual meeting and the Board of Directors candidate forms with proxy for elections. The annual meeting this year is scheduled for Tuesday, November 20th at 6:30pm in the meeting rooms of the Bayside Recreation Center. Registration will begin at 6:00PM. In addition to reviewing the 2019 budget, we will also be holding annual elections for two Board positions this year. The candidates are two incumbent Board members up for reelection – Peter Burke and Matt Ripley along with a third candidate running for a board seat – Mr. Donald Degner. If you are unable to attend the annual meeting to vote in person, please mail your election voting proxy back to The Select Group.

As a reminder, at last year's annual meeting an amendment to our documents was approved limiting rental terms in Church Point to a minimum of 1 year. This amendment applies to renting your home or even a bedroom in your home and requires that a copy of all leases be submitted to the Select Group. The rental lease will be filed in your home address folder and logged for review by the Board. Failure to submit a copy of your lease is a violation of the rules now in effect. As the homeowner, you are required to ensure your tenants are aware of the association rules to include that the tenant is responsible for maintaining the landscaping. We recently had a tenant who was not maintaining the landscaping of a rental property which detracts from the overall appearance of the community and results in the homeowner being in violation.

We realize our documents are an extremely large package of information and can be daunting and intimidating to even sit down and read. I can't stress the importance of knowing what the documents say and more so, what the rules are. We've recently had several instances of new owners not reading the documents and thus not only unfamiliar with the rules but also the required processes. We want every homeowner to be proud of living in Church Point and be great neighbors. The Board doesn't enjoy issuing violations to homeowners but has an obligation to enforce the same rules for every homeowner. The Board can't see or be aware of everything that occurs in the community and we rely on all homeowners to assist us in keeping our community looking great. If you see violations, vandalism, damage to our community, tree limbs down, or safety concerns, please don't hesitate to reach out and notify the Association Manager so we can get these issues addressed and corrected as soon as possible.

I look forward to seeing everyone at the annual meeting on November 20<sup>th</sup>.



## Neighborhood Watch – Fall 2018 By Kim Burke and Betsy Guglielmo



We have been regularly attending the monthly VBPD 3rd Precinct community meetings and would like to pass along some statistics from the recent October meeting. Comparing the first nine months of 2017 to current 2018, we are pleased to report that burglaries are down 22.5%, larcenies are down 14% and arson is down 40.5%. Unfortunately, there was a 24.4% increase in motor vehicle thefts. Please do not leave your cars unlocked and with the holidays quickly approaching, do not leave any packages or any items in your vehicles. Please take the time to double check your vehicles to ensure they are locked - It only takes a minute. Also, be aware of packages being delivered and left on your doorstep. If you are not going to be home on time, ask a neighbor to possibly take them in for you. Doorbell camera systems are also becoming very popular and aiding the police should a theft be committed. Remember, packages left on your porch overnight are not only a target to get stolen but an easy indicator that you aren't home. If you notice anything suspicious or unusual activity, call the police non-emergency number at 385-5000.

Recently, we unfortunately just had a home burglary/break in on Church Point Road in October. The only items stolen from the home were alcohol thus indications are the culprits are possibly neighborhood kids. If you have any information related to this crime, please contact the Third Precinct Property Crime Unit or Crime Solvers. Please be vigilant in locking your home doors and making sure you keep your outside lights on at night.

To date, we currently have over 40 homeowners from Church Point enrolled in Nextdoor and it is our primary means on getting information to everyone in a quick and timely manner. Nextdoor (www.nextdoor.com) is a community specific site for the exchange of information, ideas, community events, but most importantly a communication tool to get information out to all homeowners quickly. This site is endorsed and recommended by the VBPD, since it allows for the quick dissemination of information to all the adjacent neighborhoods.





#### AREC Corner - Fall 2018

It was nice this summer to see many homeowners submitting Architectural Change Applications to improve their homes but unfortunately, we did notice homeowners executing improvements and changes without reading the rules or even submitting applications for approval prior to starting projects. The rules are in place for the primary reason of ensuring consistency and uniformity of the homes to maintain curb appeal and most importantly home values. There is a designated process for making changes to the exterior of your home and that process requires:

- 1. Download the AREC change application from the website or contact the Select Group for a copy
- 2. Complete the application which includes details of the project, material to be used and a site plan (site plans are available online from the city). Please ensure you notify your neighbors of the pending work.
- 3. Submit the application to the Select Group the Association Manager will log the application and assign it a designated tracking number.
- 4. The Select Group then forwards the recorded application to AREC.
- 5. AREC reviews the application and makes their recommendation.
- 6. Once a month, the Board of Directors reviews all applications and makes the final determination on approval.

Please do not start your projects until you receive notification on the decision of the Board of Directors. The process is quick with responses back usually within 30 days if submitted in advance of the monthly Board meeting.

Additionally, there has been an increase in homeowners submitting applications for sheds in their yards. As a reminder, sheds are specifically identified in our documents as "<u>not allowed</u>" in Church Point. There is no statute of limitations on violations so if ever in doubt or if you have questions prior to submitting applications, please don't hesitate to contact AREC via email at arec.churchpointhoa@gmail.com.

Fall brings the changing color of leaves and their eventual falling to the ground. Unfortunately, year after year, we need to remind homeowners that leaves must be bagged in clear yard waste bags for pickup by the city and in accordance with HOA rules, cannot be placed on the curb in front of your home any earlier than Tuesday (the day before trash pickup - which is of course Wednesdays). Please keep this in mind and please don't place your lawn debris and leaf bags on the curb prior to Tuesday. It is a violation to put lawn and leaf bags as well as sticks/branches on the curb before Tuesday afternoon and can result in a financial fine to the homeowner for every occurrence. Please store your bags behind the rear foundation of your home, out of site from the street, until Tuesday. The weekends and the upcoming holidays are popular times for friends and family to visit as well as prospective homeowners to tour the neighborhood looking for homes. What they don't want to see are our streets lined with leaf bags or yard debris. It is not the appearance or welcoming look we want to portray for perspective new neighbors in Church Point. Curb appeal affects all homeowners, so please do your part to help us maintain our community.

- Friday, March 22, 2019: Nacho bar and wings theme.


