Finally, it appears the temperature swings and frigid air from this winter are behind us and spring has arrived. The spring bulbs are blooming and soon our tireless Garden Club will be working hard to get spring flowers around the entrances, etc. Although it was a long, tough winter, the Board was able to execute some wonderful projects specifically around the Lake in the Mews section. As part of an approach to increased safety on the bridge for homeowners, lighting was installed to illuminate the bridge walkway. For those of you enjoying the local eateries over the bridge or out for an evening run/walk, I am sure you will agree the new lights are a welcome sight from the previous darkness along the bridge. A special thank you to Board member, Jack Palmer, for assisting me with the installation of the lights on the bridge rails. Additionally, the Board (specifically Board member Rick Little who was project manager for this project) in cooperation with the city engineers and permits, was able to complete the refurbishment of the drainage culvert entering the lake. The base of the culvert and entry to the lake were deepened and graded to ensure proper flow, the bulkheads were rebuilt with new timbers and a rubber membrane along with new rip rap installed for stabilization to prevent erosion. These changes should ensure proper and consistent flow of storm water into the lake and reduce our chances of flooding. The final piece of the project this April will be to re-landscape the entrance area of the bridge in cooperation with local homeowners and our Garden Club.

The Board also completed the replacement of the diseased honey locust trees along Church Point Road with direct support and cooperation from the City whose crews executed the plantings. Thank you to homeowners for your support of the project and to those homeowners on the opposite side of the street that took the opportunity to replace their diseased trees with new ones. Additionally, in April work will commence on the installation of a brick monument sign for the Mews Entrance. A smaller scale version of the larger brick signage at the main entrance and portions of the costs for this project came from insurance money related to the car accident that caused damaged to HOA property.

As a reminder to those owners reading this newsletter who are currently renting your homes out; you are responsible for ensuring your tenants are aware of the HOA rules and regulations. Specifically those rules about noise restrictions after 6PM on Saturday until Monday morning along with not putting trash/yard debris out on the curb before Tuesday evening. Finally, please enjoy our community this spring, our many amenities along with the terrific events planned by our Social Committee but as always, please be cautious of our youth playing outside and those getting exercise by jogging, walking or cycling. Drivers please be diligent in watching your speed and parents, please watch your kids to keep them from running or biking into traffic.

We hope everyone is doing well as the weather finally warms up, and are sorry to inform you of an increase in criminal activity in Church Point over this past winter. In January, the association received numerous reports of items taken from homeowners' yards, unlocked vehicles and garages. One homeowner in the Commons had actual security camera video of two men removing items from the owner's yard as well as rummaging through multiple vehicles. The video showed the thieves loading items in an older model, possibly late 1980's, white Ford pickup truck with a ladder rack. These individuals have been seen several times in the neighborhood and have helped themselves to anything of value from tools to generators. Several homeowners from the Commons and the Quays provided suspect descriptions along with the video footage to Police, who are actively investigating.

We cannot stress enough, the importance of keeping your doors and windows locked, and garage doors closed when not in use, especially at night. Burglars tend to work in groups and look for easy targets - please keep vehicles locked and valuables out of sight, and ensure the exterior of your home is well lit.


On another note, please keep an eye out for children playing outside. We have had numerous reports from concerned homeowners of young children at the Mews entrance of the neighborhood not paying attention to vehicles. Parents, please remind your children to not play in the street and to look both ways for cars before crossing.

As a reminder, the City of Virginia Beach still has a curfew law in effect making it unlawful from 11pm -5am for youth under age 18 to be out on city streets, parks, public spaces, etc. If at any time you see suspicious activity, call the VBPD non-emergency # 757-385-5000. 

#### AREC Corner - Spring 2014

Architectural Review and Enforcement Committee

As the warmer temperatures of spring begin to arrive, so does the opportunity for home improvement and upkeep projects. As mentioned in previous articles, if you are planning on changing anything related to the exterior architectural design of the home (additions, decks, pools, etc) which also includes colors and finishes, please ensure you submit an Architectural Change Request Form (available for printing on our website <u>www.churchpointonline.com</u> or from the Association Manager, Bob Garrett with The Select Group) prior to starting the project and with ample time for review by AREC and approval by the Board of Directors that only meet once a month. The basic premise is that if you are making a CHANGE to the exterior of your home, then an application is required to be submitted. If you are making repairs to your home (replacing rotted deck or fence boards, pressure washing, new roof of same color / type of shingle) or anything that is restoring your home it to its original appearance, color, shape, size, etc. then an application is not required but when in doubt please submit an application.

Some recent examples of changes that <u>DO</u> require an application and prior approval:

- Replacing a wood deck with concrete or pavers or changing the size/shape of a deck.
- Installing a pool
- Repainting your home a different color than current color
- Adding an addition to the home or a pier
- Reminder that no free standing structures are allowed, they must be physically connected to the home and be of the same exterior finish materials to appear as part of the home
- If a brick home then the addition must be brick. If the roof shingles are gray so must be the addition.

Finally, spring is the perfect time of year to pressure wash homes, driveways, mailboxes and <u>especially the fences along First</u> <u>Court Road which annually are in need of having the green growth removed</u>. Please remember that the fence rules are specific in that wood fences need to be cedar (clear, no knots) and not pressure treated pine. If you apply a sealant to the fence it must be clear, not color tinted. Curb appeal affects all homeowners both positive and negative so please do your part to help us maintain the curb appeal of our community.
