Neighbors,

Summer has arrived with hot and humid temperatures, kids out of school and many wonderful Social Committee events. It was a very harsh winter and several of the newly planted trees along Church Point Road unfortunately did not survive the frigid weather. The damaged trees have been noted by the landscape committee who has contacted the City. The City Landscape Division will be replacing these trees under warranty for the association and still owes several trees from the original list. All will be planted this fall when cooler temperatures are optimum for success. The trees that did survive the winter still have very immature root systems, and it is critical that they get as much water as possible to survive. Since Mother Nature has started off the summer very dry for Church Point, the Board has authorized supplemental watering of these new trees with a water truck by the landscaper through monitoring by the landscape committee. If you have a new tree in the sidewalk easement in front of your home, we request any support you can provide through extra watering with irrigation systems or hoses. It is wonderful to see tree lined streets and the future is great for these great shade producers, but we need your assistance to help the trees survive.

The Mews entrance monument sign construction is finally in progress after some challenges with City easements and Dominion Power poles / underground wiring. As of the writing of this article, the brick work is complete and we are just awaiting the arrival of the concrete matching top cap, followed by the lettering to complete the sign. Additionally, the custom metal street sign supports have arrived and new street sign installations will begin shortly to replace the smaller metal street signs and restore the uniformity of the larger street signs that are a unique feature to Church Point.

Special thank you to our dedicated Garden Club that again did the design and planting of the beautiful flowers at the entrances. The Garden Club continues to go above and beyond to enhance the curb appeal of our community. Summer brings longer days and more people out and about enjoying all our community has to offer. Summer also has kids out of school so as always, drivers please watch your speed in the neighborhood and be extremely cautious of our youth playing outside and those getting exercise by jogging, walking or cycling.



AREC Corner - Summer 2014

Spring kept AREC busy with numerous architectural change applications and we were glad to see so many homeowners working hard to enhance their homes and hopefully increase property values that will benefit all of us. There are still some owners confused by what does and does not require an AREC application. The requirements are specific - if you are making a CHANGE to the exterior of your home/yard, then an application is required to be submitted. If you are undertaking multiple simultaneous projects that are changing the exterior of your home or yard – all of those projects need to be listed on the application. When in doubt, please submit an application since it is a lot less work for the volunteers on AREC to say "thank you for submitting but an application isn't necessary" than to put AREC and the Board of Directors in a position that requires a formal hearing to be held.

For clarification - if you are making "repairs without change" or "general maintenance upkeep" to your home (replacing rotted deck or fence boards, pressure washing, new roof of same color / type of shingle) or anything that is restoring your home it to its original appearance, color, shape, size, etc. then an application is not required, but when in doubt please submit an application.

Some recent examples of maintenance and repair projects that <u>DO NOT</u> require an application and prior approval:

- Replacing rotted wood deck boards/rails, replacing rusted nails/screws or staining/sealing your deck
- Cleaning / pressure washing pavers, driveways, mailboxes and fences or applying clear sealer
- Replacing a fence of rotted cedar boards with new cedar boards in original configuration
- Repairing EIFS surfaces or mortar joints in brick
- Repainting your home / trim the same original colors
- Replacing rooted wood soffits and fascia boards
- Replacing broken or corroded exterior light fixtures

Neighborhood Watch – Summer 2014

We hope everyone is enjoying the summer. With the warmer temperatures and school being out for the summer, there tends to be increased activity. Please be cautious of door-to-door sales people/solicitors. Anyone soliciting in the City of Virginia Beach must have a permit unless they are with a non-profit, charitable, civic or religious organization. If someone comes to your door and you are ever in doubt, do not let anyone in your home, especially sales reps and solicitors you don't know. "Please see "Solicitor Requirements" provided by the City of Virginia Beach Police Department.

In the past several days, it has been brought to our attention that there are several teenagers roaming the neighborhood at approximately 3 am, seen mostly in The Mews section from the entrance to the bridge. As mentioned in previous newsletters, the City of Virginia Beach still has a Curfew Law in effect making it unlawful from 11pm - 5am for any youth under age 18 to be on city streets, parks, public spaces, etc.

Additionally, please continue to be aware of young children playing/riding bicycles in the streets, sidewalks and especially near the entrances that can dart out and change directions unexpectedly. As always, please be cautious of and give plenty of clearance to our neighbors biking and jogging throughout the community. Finally, if you go on vacation, please ensure you stop your mail and newspaper (or have a neighbor pick them up regularly for you) and it is recommended to have programmable lights in your home to make it look like you are there to help deter crime.

SOLICITOR REQUIREMENTS

Per Article II, Section 26-26 of the Virginia Beach City Code, door-to-door solicitors must have a copy of the City-issued Solicitor's permit on their person at the time they are soliciting. Solicitor's Permits are obtained from the Police Services Division located in Building 11 (Police Headquarters). The box on the right side of the permit should contain a recent photo of the solicitor presenting it. Some businesses, such as charitable, non-profit organizations, and civic or religious organizations are exempt from this requirement; please see Virginia Beach City Code Section 26-26(b) for a complete listing of those organizations and individuals that are exempt from the Solicitor's permit requirements.

Individuals soliciting for charitable, non-profit, civic or religious organizations are required to register with the VA Dept. of Agriculture and Consumer Affairs. If you are unsure about donating to a certain organization, ask for a remittance envelope and tell the solicitor you may send in a donation at a later time. Such organizations can be verified online at www.vdacs.virginia.gov or by phone during business hours with the VA Dept. of Agriculture and Consumer Affairs: (804) 786-2042. Keep in mind there are also exemptions to this requirement so some charitable/non-profit organizations may not be registered with the Commonwealth of VA.

REMEMBER: Report all suspicious individuals and activity to the Police Non-Emergency Number (385-5000); for actual crimes in progress, call 911. Never allow solicitors into your home and verify their identity before even opening your door. Trust your instincts - if you feel uneasy, ask them to leave your property.
