#### **President's Corner**

Fellow members,

It has been a routine quarter for the Association. The Board conducted a midyear review of the current budget and it appears we are in good shape for the rest of the fiscal year barring a major storm. We attempted to find a quick and inexpensive fix to our electrical problems at the main entrance and gazebo. Unfortunately, there is no easy solution. To solve the problem, we must rewire the decorative street lights at entrance and the gazebo security lights. Luckily, this will not have an adverse impact on our current budget as the funds will be drawn from our State-mandated replacement reserve. We are developing estimates for the work now and hope to have the work done before the end of summer.

As most of you know, two of the brick pillars at the entrance were covered with graffiti at the beginning of summer. The police were unable to associate the vandalism with anyone, but luckily the graffiti was not gang-related. This incident highlights our need for a neighborhood watch coordinator. Even though most of the streets have block captains in place, our watch program has been somewhat dormant since our previous coordinator departed at the beginning of summer. If you are willing to become the coordinator please contact one of the Board members.

As with all previous summers, there was an increase in building activity. Unfortunately, many of the projects lacked the Board's required authorization and violated our covenants. As result, the Board had to take corrective action in the form of stop-work-orders, fines, and removal orders. These administrative and legal actions are time consuming for the Board and expensive for the homeowner. The best way to avoid such problems is to be familiar with our covenants and to follow the guidance provided on our Web page for obtaining construction authorization. In short, if you don't have a blue permit from the Board in your window, you don't have permission for construction work.

Our annual meeting is just around the corner in October. We will need at least two new Board members. Please consider doing your share. It doesn't take much time and the work is rewarding.

### New First Court Road Hollies Need Your Help If Dry Weather Continues

The Nellie Stevens hollies planted along First Court Road in 2008 got off to a good start with last year's wet summer. But this hot, dry weather in 2010 is stressing them – along with most other plants, trees, and shrubs in the area. The drenching we got at the end of July helped, but we're still way below normal.

Residents who have hollies planted behind their houses can help speed their growth and ensure their health by giving them an occasional watering during the dry spells. Deep watering in the summer and times of low rainfall will help them get taller and fuller more quickly. A good, deep soaking from the hose once a week when it hasn't rained will do wonders. If you wish, you may leave your drip or soaker hose outside the fence. Your help is important because there is no other irrigation system available in that area. After the first few years additional watering will no longer be necessary under normal conditions.

If you have any questions about the hollies or any other plants in your yard, the **Virginia Beach Master Gardener Grow Line** is a good resource. The number is 385-8158 and it's available 9 AM – 3 PM, Monday through Friday. These helpful and knowledgeable volunteers are an excellent source for answers about plant information and problems.



### Indigo Dunes Project Appears Dead – City Plans to Buy Pleasure House Point Property and Preserve Wetlands

According to reports in the paper earlier this month, the City of Virginia Beach plans to acquire the Pleasure House Point property through a partnership with the Chesapeake Bay Foundation and other non-profit organizations and preserve the area as wetlands. This effectively ends the proposed Indigo Dunes project, which would have build over 1,100 residences on that land. The Pleasure House Point area is just the other side of Bayville Golf Club and is visible from the Church Point riverfront.

Many Church Point residents and most Shore Drive area civic associations had opposed the Indigo Dunes development for a multitude of reasons: it would have added traffic to already over-crowded Shore Drive; it would have destroyed acres of wetlands along the fragile Lynnhaven River; it would have stressed police, fire, and rescue units in the area. Despite the concerns, the project seemed to be moving ahead, but the slackening economy in the past 2 years proved to be a boon to the opponents. The falling property values stressed the developer, and the mortgage holder took ownership. This made it feasible and affordable for the City to step in and make a successful bid for the property.

It appears that the plan will allow for some commercial development on part of the property along Shore Drive. One of the stores mentioned in the newspaper as a possibility was Harris-Teeter. But nothing will be finalized until all the money is raised and the property is officially purchased later this year.
