## Work to Begin This Year on First Court Road Photenia

Details are still being worked out, but the Board of Directors has decided to set money aside this year to begin removal of the diseased photenia bushes along First Court Rd. They will be replaced by some type of holly. The Board will work with landscapers and arborists to determine the most appropriate specimens for the area.

Because of the expense of this project, it will probably be done in phases, starting with the bushes that are dead or in the worst health. The Board will be developing detailed plans for the timing and cost of the project in the coming weeks. Residents along Church Point Place whose property backs up to First Court Rd. will be notified and consulted as plans develop.

While it is difficult to measure the effectiveness of this additional coverage, we do know that we had some minor vandalism just prior to the period of additional coverage and none after the coverage went into effect. We plan to continue random coverage over the coming year. I would like to acknowledge the close cooperation of the Virginia Beach Police Department with our Neighborhood Watch Director, LaTanya Cole, and Ali Mercer of our management group Select in coordinating our overall efforts to make Church Point a safer place to live and play.

I would like to thank my fellow Board members for their support and a special thanks to all the committees and to the homeowners for all your efforts to make Church Point the best place to live in Virginia Beach. In the near future there will be an article about our Church Point neighborhood in the Virginia Pilot; look for it and stay warm through the winter.

I want to call your attention to the VB Police Department's Citizens' Advisory Committee (CAC). I usually attend these meetings monthly to represent our area, but thought that some of you would like to attend yourselves. Our next regular monthly meeting of the Citizens' Advisory Committee of the Third Police Precinct is on **February 16 at 7 PM**, in the Bayside High School cafeteria. Anyone can attend; it is open to the public.

Our meeting format usually begins with a speaker, we next have a report from the 3<sup>rd</sup> precinct, and finally representatives from the city speak. The speakers are always interesting and convey important information on crime awareness in the city.

City representatives from the fire department, code enforcement, zoning, human services, crime prevention, commonwealth attorney's office, housing and preservation, probation & parole, and the Bayside Recreation Center will also be in attendance. You are invited to remain for light refreshments.

If you would like to attend future meetings, they are always the 3<sup>rd</sup> Thursday of the month at Bayside High School on Haygood Rd. (Take Independence Blvd to Haygood, turn right at Subway & McDonalds). Bayside High is a few miles down on the right side). Park in front; we usually meet in the cafeteria whose entrance is the next to last set of doors.

### **Some Reminders**

The Declaration of Restrictions for Church Point prohibits commercial signs from being posted in the neighborhood. Some workers (especially painters and handymen) like to post a sign in your yard while they're working. Please politely tell them that it's not permitted; let's keep the neighborhood looking good!

Also, don't put lawn debris or tree branches, etc. out on the curb until the night before trash pickup; that's also one of the rules for a safer, tidier neighborhood.

#### **POOP POLLUTES!**

Hey, we all love dogs. But one of the facts of life of modern subdivision living is that dogs need their exercise and they need to poop somewhere in the development! Whether it's on the owner's lawn, the common area, or a neighbor's yard, it's important for the poop to be properly disposed of. The Virginia Beach SPCA has launched an initiative to convince dog owners that cleaning up pet waste is important to the environment. They've devoted a web page to the effort (vbspca.com/poop) and we've reprinted their poster here as a reminder. Below is their description of how Poop Pollutes:

#### The land...

Pet waste contains bacteria and parasites. Diseases that can be spread from pet waste include --

Campylobacteriosis (a bacterial infection causing diarrhea in humans)

*Salmonellosis* (the most common bacterial infection transmitted to humans from animals -- symptoms include fever, muscle aches, headache, vomiting, and diarrhea)

**Toxocarisis** (roundworms transmitted from animals to humans. Symptoms include vision loss, rash, fever, or cough).

#### The water...

Pet waste degrades water quality leading to cloudy, green water from accelerated algae and weed growth, objectionable odors, and dead fish and other organisms. Up to one fourth of the fecal coliform in the polluted Lynnhaven River is from pet waste. Pet waste left in yards as far away as Green Run eventually reaches the city's historic waterway.

#### The air...

In addition to odors, flies and other pest insects can also increase when pet waste is disposed of improperly, becoming a nuisance and adding another vector for disease transmission.

*Communities...* Finally, pet waste pollutes friendships.
